SHIPPED SEMEN BREEDING CONTRACT

Mare owner hereby agrees to breed their mare _____ Reg. No. _____
Age _____ to the Bulldashus standing at Lazy K Ranch, utilizing cooled shipped semen, and paying a
stallion service fee of \$_____. A non-refundable booking of \$200 is payable with this contract which will
reserve for the Mare owner a breeding by means of shipped semen for the 200__ season.

Prior to shipment, the Mare Owner must pay the following; Booking fee, balance of the stud fee, and a \$_____ collection / shipping fee for each Federal Express priority shipment.

Lazy K Ranch does not require a deposit on the equitainer, but in the event the equitainer is not returned, a \$300.00 fee will be charged.

Lazy K Ranch will collect the stallion Monday, Wednesday, and Friday during the breeding season. Request for shipment must be made prior to 10:00 AM Pacific Standard Time on collection days. No guarantee of delivery nor the quality of the semen at arrival is given.

The Mare Owner agrees to furnish a copy of the mare's registration papers, shipped semen forms and other information as the manager requests. The Mare Owner represents the mare is healthy and in sound breeding condition and registered with the designated registration organization.

The Mare Owner agrees that a qualified and experienced person in the use and handling of cooled semen will perform the insemination. Mare Owner agrees to use all cooled semen provided by this agreement and no other. In the event of multiple embryo flushes, the Mare Owner must execute separate contracts for each Embryo Transfer. **If embryo transfer results in multiple pregnancies, than the Mare Owner must pay the Stallion Service Fee for EACH pregnancy.**

The contract provides for a return breeding in the succeeding year only, for a mare (or agreed upon substitute) that fails to produce a live foal. This may be satisfied at the sole option of **Lazy K Ranch** by 1) shipping semen, or 2) **Lazy K Ranch** may require the rebreeding to be preformed by **Lazy K Ranch** attending veterinarian. **In no event shall any stud fee be refunded.**

It is further agreed that should the stallion die or become unfit for service, this contract shall become null and void, and any money paid as part of the stallion service fee shall be refunded to the Mare Owner.

When Mare Owner, or authorized representative signs and returns this contract to **Lazy K Ranch** it will be a binding contract on both parties, subject to the above terms and conditions. This contract is not transferable or assignable. The Mare Owner/lessee agrees that interest of 1.5 % monthly will be charged on all accounts that are over 30 days past due. The Mare Owner/lessee agrees to pay all reasonable attorney fees incurred by **Lazy K Ranch** in attempting to collect any outstanding balance
